Students in the program will be responsible for creating their own portfolio, which will include such items as resumes, sample job applications, mock interview questions, industry tour information, community outing reflections, planning guides, and a library card. Sierra's Life Skills program utilizes "experience-based learning" that stresses direct participation in order to increase motivation, acquisition, and retention of the skills being taught. GOAL

- To assure a quick, safe exit from the building for all occupants when an emergency requiring evacuation such as an earthquake or fire occurs.
- To safeguard and supervise the students until arrangements can be made for their safe return to class, an emergency shelter, or their homes.

DEFINITION

A disaster or emergency is defined as any situation that involves the potential for serious injury or illness of a student, parent, or employee. Included in this definition is fire, explosion, earthquake, riots, etc.

PROCEDURE

Disruption of communication is a serious problem during any disaster or emergency. Therefore, the school has developed a pre-established plan that designates the procedures and parties responsible for the implementation of the plan. Therefore,

- The Program Director shall assure that all students and staff members are aware of the Disaster
 and Mass Casualty Plan through an orientation program and by having copies of the plan available
 in all the classrooms and offices.
- All staff members are responsible for notifying the Program Director of potential hazards or obstructions to a safe exit from the building.
- All building exits shall be clearly identified as per code and numbered in case a specific exit must be used.

All students requiring assistance due to physical disabilities shall be identified at the beginning of the school year and a staff member shall be designated as responsible for their evacuation.
